

1 acre more or less in the Southeast Quarter of Section 23, Township 2 South, Range 6 West, described as commencing at a point 564 feet West and 425.23 feet South of the Northeast corner of the Northwest Quarter of the Southeast Quarter of Section 23, Township 2 South, Range 6 West DeSoto County, Mississippi (at the Southeast corner of the 1 acre conveyed to Jim and Brenda Burkeen by the deed in book 510 page 588) thence West 2 feet to the point of beginning, thence North 89 degrees 58min 15sec West on Burkeen's South line 264 feet to Burkeen's Southwest corner thence South 00 degrees 33 min 52 sec East 160.63 feet to a point in the North line of Peyton Subdivision (plat book 93 page 21) thence with the North line of said Subdivision South 88 degrees 52 min 52 sec East 264.52 feet to a point thence North 00 degrees 33 min 42 sec West 160.63 feet to the point of beginning.






