**QUITCLAIM DEED**

FOR AND IN CONSIDERATION of the sum of Ten Dollars (\$10.00) cash in hand paid, and other good and valuable considerations, the receipt of all of which is hereby acknowledged, I, **BARBARA DAUGHTRY HENRY**, do hereby convey and quitclaim unto, **GPHI, LLC, a Mississippi limited liability company**, all our right, title and interest in and to the land lying and being situated in DeSoto County, Mississippi described as follows, to-wit:

A thirty-foot (30') wide easement for the purpose of ingress and egress situated in the NE 1/4 of Section 36, Township 1 South, Range 7 West, DeSoto County, Mississippi, being the NW 1/4 of more particularly described as extending from Goodman Road southwardly to subject property, said easement being thirty feet (30') in width and being fifteen feet (15') off of the west side of the Pinnow tract and fifteen feet (15') off the east side of the Henry tract.

Being the same easement described in Book 160, Page 207 and Book 187, Page 726, Land Records, Chancery Clerk's Office, DeSoto County, Mississippi.

By way of explanation, the above referenced easement was originally granted by the Grantor to Danny Ray Butler and wife, Patricia Daughtry Butler. The language in the easement stated that Barbara Henry reserves the use of said easement. Therefore, the purpose of this document and the intent of the Grantor is to relinquish any and all interest in said easement.


