FOR AND IN CONSIDERATION of the sum of Ten Dollars (\$10.00) cash in hand paid, and other good and valuable considerations, the receipt and sufficiency of all of which are hereby acknowledged, DIANE (KRIEGER) COLEMAN and AUBREY ALLEN COLEMAN do hereby grant, bargain, sell, convey, release, and forever quitclaim unto DIANE (KRIEGER) COLEMAN, here present and accepting for themselves, their heirs and assigns, all of their right, title and interest in and to the land lying and being situated in DeSoto County, Mississippi, and being more particularly described as follows, to-wit:

Beginning at a point, being the intersection of the southwest line of U.S. Highway 78 and the south line of Craft Road (New State Road) in Section 20, Township 1 South, Range 6 West, DeSoto County, Mississippi; thence North 82 degrees 22 minutes 45 seconds West with the south right-of-way of Craft Road 402.78 feet to a point; thence South 51 degrees 50 minutes 30 seconds West with the South right-of-way of Craft Road 237.71 feet to a point, said point being the true point of beginning for the tract herein described; thence continue South 51 degrees 50 minutes 30 seconds West with the South right-of-way of Craft Road 68.0 feet to a point; thence South 29 degrees 15 minutes 45 seconds East 739.03 feet to a point; thence North 59 degrees 18 minutes 58 seconds East 150.55 feet to a point; thence South 63 degrees 17 minutes 07 seconds East 210.89 feet to a point; thence North 26 degrees 42 minutes 53 seconds East 144.99 feet to a point; thence North 61 degrees 17 minutes 17 seconds West 174.35 feet to a point; thence North 47 degrees 45 minutes 35 seconds West 726.54 feet to a point being the true point of beginning, containing 3.81 acres, and being situated in Section 20, Township 1 South, Range 6 West, DeSoto County, Mississippi. 
