SUBSTITUTED TRUSTEES DEED

WHEREAS, on November 8, 2002, Raymond L. Wilson, an Unmarried Person executed a Deed of Trust to Diane L. Slack and Todd Goodhart, Trustee for the benefit of Fieldstone Mortgage Company, which Deed of Trust is filed for record in Book 1610 at Page 299 and re-recorded in Book 2,884 at Page 154 in the office of the Chancery Clerk of DeSoto County at Hernando, Mississippi; and
