SPECIALWARRANTY DEED

FOR AND IN CONSIDERATION of Ten Dollars (\$10.00) cash in hand paid and other good and valuable consideration, Deutsche Bank National Trust Company as Trustee under Pooling and Servicing Agreement Dated as of July 1, 2005 Morgan Stanley ABS Capital I Inc. Trust 2005-HE3 Mortgage Pass Through Certificates, Series 2005-HE3 (hereinafter called "Grantors") do hereby grant, bargain, sell, convey and warrant unto Bobby J. Stamm and Brittany R. Stamm, as joint tenants with full rights of survivorship and not as tenants in common (hereinafter called the "Grantees"), the following described property lying and being situated in DeSoto County, Mississippi, and more particularly described as follows, to-wit:

GRANTOR covenants that it is seized and possessed of the said land and has a right to convey it, and warrants the title against the lawful claims of all persons claiming by, through, and under it, but not further otherwise.


Grantor conveys the property described herein subject to the following:

- (5) Ad valorem taxes, fees and assessments, if any, for the current year and all prior and subsequent years, the payment of which Grantee assumes (at the time of transfer of title), and all subsequent assessments for this and all proper years due to changes(s) in land usage (including, but not limited to, the presence or absence of improvements, if any, on the Property), ownership, or both, the payment of which Grantee assumes; and
- (6) Any conditions that would be revealed by a physical inspection and survey of the Property.


