QUIT CLAIM DEED

FOR AND IN CONSIDERATION of TEN AND NO/100 (\$10.00) cash in hand this day, and other good and valuable consideration, the receipt and sufficiency of all of which is hereby acknowledged, We, W. T. Wilson, James Kimble Wilson, George Wilson, Iprima Black, M.D. Wilson, Jr., Nellie Wilson Sartin, Lori Bryson and Mary Wilson McKinney, Grantors, being all the heirs of Nellie Lee Wilson Taylor, do hereby bargain, sell, remise, release, quit claim and convey unto W.T. Wilson and M.D. Wilson, the real property located in DeSoto County, Mississippi, described as follows, to-wit:

One (1) acre, situated in the Southwest Quarter of Section Thirty Five (35), Township Two (2), Range Seven (7) West, said lands being in the shape of a square and being more particularly described by metes and bounds as follows, to-wit:

Beginning at a point in the North right of way of Byhalia paved road, which point is 10 chains East of hte West line of said Section 35, and which point is the Southwest corner of the Q. D. Woods home place; thence East along the North right of way of said Road 210 feet to a point; thence North a distance of 210 feet to a point; thence West a distance of 210 feet to a point; thence South a distance of 210 feet to the point of beginning.
