2. That the sum of \$20,709.62 be transferred from BROOKS ADRIAN BUMPOUS to the DUDLEY RUDOLPH BUMPOUS Conservatorship, RODNEY BUMPOUS and DON BUMPOUS, Co-Conservators, on or before, Tuesday, September 16, 2008;




3. That the request for payment of attorney fees by the Movants is taken under advisement.


SO ORDERED, ADJUDGED AND DECREED this the 9th day of September, 2008 and entered nunc pro tunc on the 15th day of September, 2008.
