NOW, THEREFORE, the Grove Park Homeowners Association Board of Directors hereby supplements said Grove Park Covenants filed at Deed Book 426, Page 669 covering and applying to all lots in Sections A as recorded in Plat Book 80, Page 7, Section B as recorded in Plat Book 85, Page 32, and Section C as recorded in Plat Book 100, Page 4.
