**ORDER CLOSING ESTATE AND FINALLY DISCHARGING
ADMINISTRATOR**

This day this cause came on to be heard upon the Petition To Close Estate And Discharge Administrator filed by Martin Angel, the duly qualified and appointed Administrator of said estate, and the Court, after considering same does hereby find and adjudicate as follows:

1. That the Court has jurisdiction of the parties and the subject matter to this action.
2. That Petitioner is the duly appointed and acting Administrator of the Estate of Profirio Angel, deceased, having been appointed by this Court by Order dated January 31st, 2008, on file in this cause.
3. That Letters Of Administration were issued to Petitioner on or about January 31st, 2008.
4. That Petitioner determined creditors, if any, who might have claims against the decedent's estate. That as a condition precedent to the publication of the aforesaid Notice To Creditors, the Administrator filed in this cause an Affidavit stating he had made a reasonable and diligent effort to identify persons having claims against the estate and that he gave notice by mail as required by Section 91-7-145(1) of the Mississippi Code of 1972, Annotated and Amended. That Petitioner caused to be published a Notice

To Creditors in the time and manner as required by law in the New Albany Gazette, a newspaper having a general circulation in Union County, Mississippi. That Proof of Publication is on file in this cause; that the ninety (90) day period for the probate of claims against the said estate has expired and no claims were filed against said estate.

5. That decedent died on or about May 11th, 2007, having a fixed place of residence in Union County, Mississippi, and owning real and personal property situated in Union County, Mississippi, DeSoto County, Mississippi, and Panola County, Mississippi.

6. That there were no claims filed in this cause.

7. That decedent's assets at the time of his death were a house and real property located at 1026 County Road 99, New Albany, Mississippi; a house and property located at Lot 100, Morrow Crest North, DeSoto County, Mississippi; and real property located in Panola County, Mississippi. That the decedent's wife, Teresa Angel, and four (4) children, namely: Martin Angel, Petitioner herein, Rafael Angel, Juanita Angel and Ramona Angel, acknowledge receipt of such property as his surviving heirs at law.

8. That there were no Federal or State income or Estate taxes due and payable by the Estate. That there were no Federal or State Fiduciary taxes owed by the Estate.

9. That Petitioner employed the services of James W. Amos, Attorney, to represent him in this matter and that the Court shall allow the Petitioner to pay a reasonable fee to said attorney for his services and expenses.

10. That decedent died intestate leaving his wife, Teresa Angel, and four (4) children as surviving heirs at law, namely: Martin Angel, Rafael Angel, Juanita Angel

and Ramona Angel. That the said heirs at law joined in the Petition on file in this cause for all purposes waiving the necessity of bond, accounting, inventory and appraisal of the Estate of Profirio Angel, deceased.

IT IS THEREFORE, ORDERED, ADJUDGED AND DECREED that the Petitioner, Martin Angel, is authorized to pay unto James W. Amos, Attorney, the sum of \$1,500.00 for his attorney fees and expenses from the assets of the estate.
