






**DESCRIPTION OF A 6.39 ACRE PARCEL OF THE COUCH-DAVIS TRACT IN PART OF THE NORTHWEST QUARTER OF SECTION 22; TOWNSHIP 3 SOUTH; RANGE 7 WEST; DESOTO COUNTY, MISSISSIPPI.**

Beginning at the intersection of the centerline of Getwell Road and the south right of way of Holly Springs Road ( 60 feet wide), said point being 934.64 feet south of the northwest corner of Section 22; Township 3 South; Range 7 West; thence southeastward along the south right of way of Holly Springs Road as follows: South 63 degrees 56 minutes 36 seconds East for a distance of 190.00 feet to a point; thence South 66 degrees 43 minutes 29 seconds East for a distance of 358.27 feet to the northwest corner of the Gurley lot; thence South 04 degrees 22 minutes 07 seconds East for a distance 385.83 feet; thence South 12 degrees 14 minutes 00 seconds East for a distance of 229.32 feet to a point; thence South 32 degrees 32 minutes 00 seconds West for a distance of 145.86 feet to the southeast corner of the Flowers lot; thence North 01 degrees 41 minutes 20 seconds West for a distance of 317.13 feet to the northeast corner of the Flowers lot; thence South 89 degrees 08 minutes 15 seconds West for a distance of 462.90 feet to a pk nail (found) in the centerline of the above mentioned Getwell Road; thence along the centerline of said Getwell Road as follows: North 02 degrees 05 minutes 00 seconds West for a distance of 254.00 feet; North 02 degrees 14 minutes 17 seconds West for a distance of 276.08 feet; North 03 degrees 29 minutes 09 seconds West for a distance of 117.34 feet to the intersection of the centerline of Getwell Road and the south right of way of Holly Springs Road, said point being the Point of Beginning.

All lying and being in the Northwest Quarter of Section 22, Township 3 South, Range 7 West, DeSoto County, Mississippi, and containing 6.39 acres, more or less.
