HILL, JR., AND THOMAS WHITE**, as Trustees in office for **SOLID ROCK ENTERPRISES**, a Pure, Private, Non-Statutory, Non-Associated, Unincorporated Business Trust Organization, do hereby sell, convey and warrant unto **ROBERT CATES, GREG L. HILL, JR., AND THOMAS WHITE**, as Trustees and their Successors in office for **GRACE BAPTIST CHURCH**, the land lying and being situated in DeSoto County, Mississippi, described as follows, to-wit:

A 10 acre tract out of the Southeast Quarter of Section 28, Township 1-South, Range 5-West, DeSoto County, Mississippi being more particularly described as follows:

Beginning at a point in the north line of Goodman Road (as monumented and being 40 ft. north of the physical centerline of the existing paving) a distance of 609.5 ft. South 88 deg. 15 min. 13 sec. West from the intersection of said north line with an old fence and tree line being recognized as the DeSoto-Marshall County Line and also being recognized as the east line of said Section 28; thence run South 88 deg. 15 min. 13 sec. West along the north line of Goodman Road, as monumented, 311.85 ft., to a point; thence run North 1 deg. 02 min. 55 sec. West, 1,397.72 ft. to a point in an old fence; thence run North 88 deg. 34 min. ~~33~~ <sup>53</sup> sec.\* - West from the intersection of said fence with the aforesaid old fence and tree line recognized as the Section Line and County Line; thence run South 1 deg. 02 min. 51 sec. East, 1,395.94<sup>ft.</sup> to the point of beginning, containing 10 acres, easements of record if any and to additional right of way of Goodman Rd., if any.


