

**ORDER OF THE MAYOR AND BOARD OF ALDERMEN OF THE
CITY OF OLIVE BRANCH, MISSISSIPPI APPROVING
PLAT REVISION - HACKS CROSS BUSINESS CENTER SUBDIVISION**

WHEREAS, Mr. Kevin Doddridge, representing Northcentral Electric Mississippi Power Association, is requesting approval of a revision to certain recorded plats for Hacks Cross Business Center Subdivision, located east of Hacks Cross Road, south of U. S. Highway 178, and north of U. S. Highway 78, and being situated in Section 12, Township 2 South, Range 6 West, and

WHEREAS, Northcentral has recently constructed a new headquarters campus on property immediately to the east of the Hacks Cross Business Center development, and

WHEREAS, Northcentral currently obtains access to its property through a subdivision street known as "Commerce Loop," and

WHEREAS, Northcentral is requesting that the name of this street be changed from "Commerce Loop" to "Northcentral Way," and

WHEREAS, the Mayor and Board of Aldermen have reviewed the matter and are of the opinion that this Order should be recorded noting the name change of the street to "Northcentral Way" and that a marginal notation should be made on the appropriate plats, and

WHEREAS, the Mayor and Board of Aldermen have authority to approve this revision pursuant to Miss. Code Ann. Section 17-1-23 and find as fact that there are no adversely affected parties pertaining to this revision.

NOW, THEREFORE, BE IT ORDERED by the Mayor and Board of Aldermen of the City of Olive Branch, Mississippi as follows, to wit:


